Overview



Fleets Responsibility

The Fleet Division under the Public Works Department is responsible for procuring and maintaining the city's vehicles.

The Division ensures:

- The right quantity of vehicles to support staff,
- Vehicles are upfitted with necessary, aftermarket equipment,
- The right type/class of vehicle are provided,
- · Vehicles available at the right time, and
- Vehicles meet state and federal compliance.




Fleet size

The City of Corona currently has a total of 410 vehicles

- 229 are city-owned or have been directly purchased
- 181 are leased through Enterprise Fleet Management (Enterprise)
- All departments are currently leasing vehicles from Enterprise




Purchased Vehicle Classes





Purchased Vehicle Profiles





Overview



Lease Option



In 2016, the City entered into a contract with Enterprise Fleet Management, allowing the City the option to lease its vehicles.

Advantages

- Vehicles could either be sourced locally or ordered from a manufacturer.
- Vehicles can be tailored or upfitted to meet all safety and compliance standards.
- Maintenance of the vehicle is included in the contract or lease price.
- Leased vehicle turnover is 4-5 years, keeping city's fleet new and updated.
- There is an overall cost savings for leased vehicles compared to a purchased or owned vehicle.


Limitations

- Not every vehicle is available for leasing.
- Some vehicles for certain types of usage will not benefit from the leasing program.
- Staff assigned to the vehicle is responsible for the upkeep.

Summary - Fleet Utilization

Summary

- Fleet works with all departments to determine which vehicles to purchase or lease.
- Fleet may directly purchase vehicles (city owned) and has the option to lease.

- Continue to monitor the efficiency of the purchasing and leasing program.
- Replace city-owned vehicles with leased vehicles, when appropriate and cost effective.
