**2.** GPCD2024-0009: Request for a General Plan Consistency Determination regarding the acquisition of 0.06 acres of property located at 425 Corona Mall. (Applicant: Ashley Zaragoza, City of Corona Economic Development Department)

The Consent Item was not pulled for discussion by Commission.

The Commission inquired on details of the Downtown property acquisition project led by the Economic Development Department; and staff provided clarification.

A motion was made by Commissioner Siqueland, seconded by Vice Chair Vernon, that the Planning and Housing Commission adopt Resolution No. 2645 determining that the acquisition of 0.06 acres of property located at 425 Corona Mall is in conformance with the City's General Plan. #### **PUBLIC HEARINGS**

3. PP2023-0007 (CONTINUED): Precise Plan application for the review of the site plan, architecture, landscaping and other features associated with the development of a 1,900-square-foot restaurant with drive-through services, aas station with seven double-sided fuel pumps, and 3,750-square-foot convenience store on 1.40 acres located on the north side of 2nd Street, approximately 450 feet west of Buena Vista Avenue. (Applicant: Greens Development)

Sandra Vanian, Planning Manager, informed the Commission that the applicant for PP2023-0007 is in the process of revising their application. She mentioned that the item will tentatively be re-noticed for the month of September 2024.

Joe Morgan, resident, provided comments on this continued item.

**4.** SPA2024-0001: Specific Plan Amendment to the Downtown Revitalization Specific Plan amending the general residential guidelines. (Applicant: City of Corona)

Joanne Coletta, Director of Planning and Development Department, reviewed the staff report and exhibits for SPA2024-0001.

The Commission inquired on various details of this item and on a related future zone text amendment; and Ms. Coletta provided clarification.

Chair Woody opened the public hearing.
